Clay County Division F Procedures and Ex Parte Calendar

Beginning June 1, 2018, the following change to trial set procedures for family cases in Division F takes effect.

Trial may not be set in any family law matter unless the parties have attended mediation.

To clarify, if you are coming to ex parte to set your case for trial, this means you have already attended mediation, not just scheduled it or are planning to schedule it.
